School, formerly known as

Crittenden County Middle

School, is a historic middle

school building located near Clyde, Benton County, Kentucky. It was built in 1913 by the Works Progress Administration and operated by the Crittenden County Board of Education. The white, three-story building is in the Classical Revival style. It features a central three-story cylindrical tower with a bellcast roof and engaged Doric order columns supporting the roof. Also on the property is the contributing original frame gymnasium (1913), the remains of the superintendent's residence (1909-1913) and garage (1913),

and a very large, historically important Italianate gymnasium (1893, rebuilt 1927) built by a separate school district to the west of Crittenden County. It was listed on the National Register of Historic Places in 2001. [References](#) [External links](#)
