That there were other reasons for committing suicide is confirmed by his suicide note, where he makes clear that he was tired of his life and that a parental-substitute relationship was not the right environment for him." The court concluded, after considering all the evidence, that defendant showed no remorse or understanding of his conduct and that he had not demonstrated that he could be rehabilitated. The court concluded that, pursuant to General Statutes (Rev. to 2007) § 53a-35a (j), defendant was in need of correctional treatment that could be provided most effectively by commitment to a secure treatment facility. The court then ordered defendant committed to the custody of the commissioner of correction. This appeal followed. Additional facts will be set forth as necessary.
