JPEG, which is short for Joint Photographic Experts Group, is the most commonly used format for images in print and on the Web. It's considered the standard format for improving and sending image-quality files. Although JPEG is fine for print, it looks terrible if you try to get it printed at an office or photo center. If you are uploading a JPEG to a web server, you will want to convert it into a TIFF or PSD. Photoshop uses .jpg files. You can use Photoshop to create a .jpg file, but it's certainly easier to create a new image with the correct size, resolution, and file format. To create a .jpg file in Photoshop, follow these steps: 1. Choose File→New, or press +N. 2. In the New dialog box, select JPEG from the Format drop-down list (see Figure 6-1). **Figure 6-1:** Create a new JPEG image. 3. Use the Resize pop-up box to specify the desired file size. As with most of the other settings, use the default settings. 4. Click OK. To open a new file in Photoshop, you can either choose File→New or go to the Create menu and select New. When you save your file, the Photoshop defaults to a .jpg extension, although you can specify a different extension if you want to, for example, save a .jpg file as a .psd or .tiff. You can save multiple images of the same size as one file, or you can group a series of different images together into one file. In my usercontrol viewmodel, I have created a method which will create a new Stock object and bind it to the controls on the viewmodel. I have done this by creating an extension to the stock class and creating an factory method. When I call Invoke on my factory with an instance of the viewmodel, however, I get back a CollectionViewItem instead of a Stock object. . Connick, 959 S.W.2d 647, 656 (Tex. App.Houston [1st Dist.] 1997, no writ). Even when a case involves factual disputes, the trial court must defer to the jury=s resolution of the conflicts. Id. at 584 (citing Montoya v. Southland Life Ins. Co., 555 S.W.2d 165, 168 (Tex. 1977)). Having reviewed the evidence under the traditional sufficiency standard, we hold that the jury finding of negligence was supported by evidence of probative force sufficient to raise a fact issue; therefore, Appellees produced more than a scintilla of evidence supporting the jury=s finding of negligence. See Merrell Dow Pharmaceuticals, Inc., 953 S.W.2d at 509. Moreover, this evidence was not so weak as to support a contrary verdict or so greatly overwhelming as to render the findings in favor of Appellees inevitable. See Cain, 709 S.W.2d at 176; Pool, 715 S.W.2d at 635; Burrell, 899 S.W.2d at 788. Appellants argue that the trial court erred when it allowed Appellees= expert witness to testify that Appellants would be liable even though Appellees did not sue Appellants and did not allege negligence against Appellants in the trial court. However, Appellants cite no authority supporting their contention. See Tex. R. App. P. 38.1(h). An issue must be supported by argument and authority; a party may not merely cite a case or an appendix and then expect the appellate court to do its research on that party=s behalf. Id. (citing Harris County Appraisal Dist. v. Randall, 880 S.W.2d 569, 570 (Tex. App.Houston [1st Dist.] 1994, writ denied)). Issue one is overruled.
