DOWNEY, Judge. This is an interlocutory appeal from
an order striking appellants' motion for summary
judgment. A motion for summary judgment is properly
granted only when the pleadings, depositions and
admissions on file, together with the affidavits, if any,

show that there is no genuine issue as to any material fact and that the moving party is entitled to a judgment as a matter of law. *Parfet v. State*, 334 So.2d 154 (Fla. 1st DCA 1976). The depositions and affidavits show that appellees, a group of approximately 15,000 individuals, were solicited by the appellants, a group of approximately 1,000 individuals, to participate in a fund raising drive known as "Operation Santa Claus." In return, appellees gave appellants their name and signature to be used as fundraisers. Appellees made more than 500 pledges. Prior to January 15, 1976, appellants made payments to the bank account of appellees which were initiated by appellees. After January 15, 1976, it was ascertained that the funds were not in the bank account of appellees, but were in the hands of appellants. It was originally a training school for nurses, but is now a 40-bed facility for the homeless as well as providing support and housing for those in recovery from all kinds of addictions. The Mission also provides a safe, affordable housing alternative for low income New Yorkers. The Mission's trauma-informed approach helps the patients heal and learn to provide for themselves, thanks to its' Good Samaritan program that provides meaningful employment for many long-

term residents. In 2014, Bowery Mews was open. Seven single-family homes were added for seniors and persons with disabilities. They are conveniently located within walking distance from the Mission and the #7 train stop, and within a short drive to Times Square. The present invention relates to an electronic ballast for use in luminaires, and more particularly to an electronic ballast which provides increased ease of lighting adjustment. Electronic ballasts are being used increasingly in the field of luminaires. Such electronic ballasts are used to replace the old type of tungsten halogen or quartz-iodine ballasts. Tungsten halogen ballasts are relatively inexpensive, but provide a high level of light in an unfocussed, high-spread beam. Quartz-iodine ballasts are more expensive and more robust than tungsten halogen ballasts, but are also more focussed and provide a better level of light output. More recently, electronic ballasts are being used in luminaires which provide a high level of light output, but at low cost. A more focussed beam of light

is provided by the use of an electronic ballast, as compared with conventional tungsten halogen or quartz-iodine ballasts. This is due to the fact that electronic ballasts can be operated with a lower ballast voltage than conventional ballasts. An electronic ballast which produces a very good level of light in a low-cost, high-output luminaire is described in our co-pending UK 6d1f23a050
